

#### **Owner News**

Outfield Resort Group may have contacted you recently offering you some additional options to add more value to your ownership. Outfield Resort Group was founded in 2002 and their goal is to provide value-based solutions that optimize usage and value for timeshare owners. The centerpiece of their business philosophy is integrity. We are expecting to have them onsite soon as our timeshare sales company. In early July, we increased the property fee we charge to our hotel guests to \$12.95 per day. In the fall, we will be adding that fee to our exchange guests that trade in from other resorts. This fee is not charged to our owners and helps us to provide the most affordable semi-annual maintenance fees in the industry to you, the Christie Lodge Owners.

After spending over 1.2 million dollars to improve our back parking garage, we have implemented some new policies relating to additional cars and trailers towed onto the property. Complimentary parking is limited to one car per one-bedroom, two for a three-bedroom. Additional parking may be available for \$10 per day and is subject to availability. Single axel trailers must remain attached to vehicle and must not exceed 7,000 GVW. A daily charge of \$25 applies to trailers. All vehicles must be registered with the front desk.

We pride ourselves in providing great value to our owners. Due to the increasing costs of cleaning our rooms and staffing the resort, we have found it necessary to make some changes to our bonus night program. We now have a two-night minimum requirement initiated for bonus nights, unless it is the day before or after your week's stay. If you are looking to stay at The Christie Lodge and do not qualify for a bonus night, we will always provide you with a significant discount off the current nightly rate.

We have also restructured our mail/package policies and now charge a fee of \$5 per letter and \$20 per incoming package. We will not hold items more than 3 days prior to arrival.

#### Vail Resorts 21/22 Season



Vail and Beaver Creek Resorts are not currently planning to have a reservation system for this coming season and have reduced all Epic Passes by 20%! This pass must be purchased by September 6th to get the best discount. Beaver Creek Resort broke ground on their 250-acre expansion of beginner and intermediate ski terrain high atop the mountain with expansive views of the Sawatch and Gore Mountain ranges. This new McCoy Park terrain will include two new detachable quad lifts, seventeen new alpine skiing trails and a smaller network of Nordic trails. This year will be a great opportunity to come visit and enjoy our winter wonderland.

## **Property Updates**

We listened and appreciate the feedback our owners provide us on the future improvements of the property. We are happy to report that all of the beds in the bedrooms have now been replaced with a Serta Perfect Sleeper Platinum Suite II Plush mattress placed on a platform base. We are expecting to replace the sleeper couch in the living room area with a couch/pull-down murphy bed in the fall and hope to complete this project by the winter season.



On the afternoon of July 22, 2021 a mudslide, suddenly and without warning, swept through the Town of Avon. Many structures, including The Christie Lodge received significant damage. Our team was quick to respond and after many hours of hard work, our maintenance and housekeeping teams were able to get our outdoor pool and hot tub facilities back up and running.
